§ 1 Scope

§ 2 Conclusion of contract

The use of all services at www.pieweb.com and the purchase of the printed PIE – Plastics Information Europe is available to subscribers only. The subscription is automatically renewed for 12 months at the going fee unless it is cancelled up to 4 weeks before the end of the previous subscription period. Our cancellation confirmation serves as receipt of the termination of subscription.

§ 3 Use/Delivery

The online service is available at www.pieweb.com and can be accessed from your personal user account. The printed newsletter will be delivered by post and will be published twice a month.

The availability of www.pieweb.com is subject to the restrictions that typically apply to internet offers, e.g. temporary unavailability due to maintenance or disruption due to force majeure. In the case of non-appearance of the printed newsletter due to force majeure, the right to delivery expires. Subscription or postage fees will not be refunded. In the case of late payments, PIE reserves the right to cease or bar delivery following a previous warning. Place of jurisdiction is Bad Homburg, Germany.

§ 4 Right of use
